

INTERNATIONAL JOOI BOARD OF DIRECTORS CODE OF CONDUCT

(The following Code of Conduct has been established by the International JOOI Board of Directors and Youth Clubs Committee. All International JOOI Board Members are expected to follow the rules.)

- 1.) No alcoholic beverages or drugs of any nature (with the exception of prescribed medication) will be permitted in the possession of any member of the International JOOI Board of Directors.
- 2.) A retiring hour of 12 a.m. will be observed and enforced. Members of the International JOOI Board are expected to be in their own rooms at this retiring hour, and they are expected to remain there, with exception of consent from their adult Advisor/Chaperone.
- 3.) Care should be taken not to deface or destroy any property or to throw any objects from windows. All damages will be paid for by the individual(s) responsible.
- 4.) Gambling, use of fire crackers, fireworks (in brief, any action unbecoming to an International JOOI Board Member) will not be allowed.
- 5.) International JOOI Board members are expected to conduct themselves as responsible young adults and are expected to attend **ALL** sessions and activities unless assigned to another duty by their adult Advisor/Chaperone. Appropriate attire is mandatory for all activities where representing the JOOI Organization. Clothing that may cause distractions during any function (in brief, attire unbecoming of an International JOOI Board member) will not be allowed.
- 6.) International JOOI Board Members are not allowed to visit Hospitality Suites unless accompanied by their adult Advisor or Chaperone.
- 7.) There will be no coed delegate room assignments at any JOOI function.
- 8.) International JOOI Board members will adhere to the authority of every Sergeant at Arms and Staff member.
- 9.) Smoking is prohibited at **ALL** general sessions, programs and workshops. Those legally able to smoke are asked to do so in designated areas.
- 10.) Pending a decision by the International JOOI Board and Youth Clubs Committee, gross misconduct on the part of an International JOOI Board member could possibly result in disciplinary actions leading to the suspension of that International JOOI Board Member's rights to function as an International JOOI Board Member.
- 11.) The JOOI Clubs Staff will report all infractions of the Code of Conduct to the International JOOI Board of Directors, Youth Clubs Committee, and appropriate adult Advisor/Chaperones.

THE APPROPRIATE ACTION WILL BE TAKEN FOR ANY INFRACTIONS OF THIS CODE, INCLUDING THE DISMISSAL OF ANY INTERNATIONAL JOOI BOARD MEMBER AT THEIR OWN EXPENSE. IN ADDITION, A DETAILED LETTER WILL BE SENT TO HIS/HER PARENTS, SCHOOL AUTHORITIES AND THE PRESIDENT OF THE SPONSORING OPTIMIST CLUB AND THE YOUTH CLUBS COMMITTEE.
